At the end of the quote put the period after the last word of the sentence followed by the parentheses. For APA, you use the authors' surnames only and the year of publication in text. If you are using a direct quote, you will also need to use a page number. If you are using the authors' names as part of the sentence, normal sentence rules apply - always use "and", and never us an "&". However, if you haven't mentioned your authors in the sentence, and they are in the brackets, follow the style rules and always use an "&".
