Citing a Source within a Source - MLA Citation Examples ...

Give the title either in the text or in a parenthetical citation. In a parenthetical citation, give the full title only if it is brief; shorten the title to the first two or three main words (excluding a, an, or the). For example: At about age seven, children begin to use appropriate gestures with their stories (Gardner, Arts 144-145).

An in-text citation is required if you paraphrase (use someone else's ideas in your own words), summarise (use a brief account of someone else's ideas), quote (use someone else's exact words) or copy (use someone else's figures, tables or structure). When citing references within the text of an assignment, you need the author's surname/family name or organisation name plus the year of publication and potentially a page number:

References List and In-Text Citations. If you are citing a source quoted within another source, only the secondary source is included on your references list. There is no need to note that you are quoting a source within the source as part of this reference. When citing quoted material in the body of your text, mention the original source in the sentence and the secondary source in a parenthetical citation at the end of the line.

How to Cite a Reference Within a Reference in APA Format ...

Go to 7th edition guidelines. Use secondary sources sparingly, for instance, when the original work is out of print, unavailable through usual sources, or not available in English. Give the secondary source in the reference list; in text, name the original work and give a citation for the secondary source. For example, if Allport's work is cited in Nicholson and you did not read Allport's work, list the Nicholson reference in the reference list.

How do you cite a source that you found in another source ...

There are two main ways to format an in-text citation: Parenthetical citation or Narrative citation. Parenthetical citation: Put all the citation information at the end of the sentence: Narrative citation: Include some of the citation information as part of the sentence: Each source cited in-text must also be listed in your References list.

Use the author's name and year for in-text citations. When you either paraphrase or quote the source directly, place a parenthetical citation at the end of the sentence. Type the author's last name, followed by a comma, then the year the book was published. Place a period outside the closing parentheses.

If you cite from different volumes of a multivolume work, always include the volume number followed by a colon. Put a space after the colon, then provide the page number (s). (If you only cite from one volume, provide only the page number in parentheses.)... as Quintilian wrote in Institutio Oratoria (1: 14-17).

Include the appropriate addition to the in-text citation to show that you are citing an indirect source. This differs based on the citation system. Although MLA discourages indirect sources, if used, the parenthetical citation should use "qtd. in" before the typical MLA citation.

1. Start your Works Cited entry with the author's name, if provided. If an individual author is listed for the web page you want to cite, type their last name first, followed by a comma, then their first name. Place a period at the end of the name.

If you use a quotation from an author, summarize or paraphrase another person's ideas or research, you must identify (cite) the source of that information within the body of your paper. These citations are called parenthetical or in-text citations because the citation may be in parentheses at the end of the quotation or paraphrase.

In your in-text citation identify the primary source, and include in parentheses " (as cited in Author, Date)". The reference list will only list the secondary source. In the examples below, Smith's study is the primary source and Queenan et al. is the secondary ("as cited in") source.

How do I cite a secondary source (a quote within a quote ...

Type the entire quotation on the new margin, and indent the first line of any subsequent paragraph within the quotation 1/2 inch from the new margin. Maintain double-spacing throughout, but do not add an extra blank line before or after it. The parenthetical citation should come after the closing punctuation mark.

Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source. For every in-text citation in your paper, there must be a corresponding entry in your reference list. APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005).

In the in-text (parenthetical) citation, include the original source name/s as well as the source you actually read (use [cited in]). In the bibliography, include both the original source and the details of the source that you have actually read. Example of Parenthetical citation (In Text) (Zukofsky 1931, 269 cited in Costello 1981, 78)

The basic rule is that in both your Works Cited list and in-text citation you will still cite Kirkey. Smith does not appear in your Works Cited list. For the in-text citation you cite Kirkey and add the words [qtd. in] at the beginning of your in-text citation. Examples of in-text citations:
